Certificate of Insurance Guidance Form for Commercial Accounts

Dear Commercial Account Customer / Insurance Provider:

In lieu of purchasing Budget Truck Protection plans, a Certificate of Automobile Liability Insurance may be provided.

Please note: the COI must be valid and transmitted to Budget Truck to be considered valid. If Budget is not presented with the COI, **we will charge you for coverage and such payment is nonrefundable**. The Certificate must be approved and added to the existing commercial account **PRIOR** to renting a Budget Truck.

The following criteria must be included as evidence of applicable coverages:

1. **TYPE OF INSURANCE:**

Must include trucks and designate at least one of the following within the **Auto Liability** section of the COI. General Liability only COI's will not be accepted. Producer info must be included: Phone number, and email address. Underwriter **must** include NAIC #.

- **any auto**
- **hired auto**
- **non-owned**
- **scheduled auto: Please note:** It is the **customers responsibility** to inform their insurance company of new Vin #'s and, to have an updated COI returned to Avis Budget Group. Failure to do so may result in having to pay Physical Damage and Liability coverages through Avis Budget Group.

2. **EXPIRATION DATE:**

A **current** COI is required and will be applied from the time received (they will not be backdated). (Expired COI's not accepted)

3. **COMBINED SINGLE LIMIT:**

Amounts for bodily injury and property damage must equal or exceed: **\$750,000**

*If Fireworks are to be transported, the Combined Single Limit must equal or exceed:

- **\$1,000,000** – if Consumer Fireworks (US DOT 1.4G)
- **\$5,000,000** – if Commercial Fireworks (US DOT HM DIV 1.3G, 1.1G)

4. **HIRED AUTO PHYSICAL DAMAGE:**

5. **DESCRIPTION OF OPERATIONS:**

*Additional Insured must include Auto Liability

If the policy includes Hired-Auto Physical Damage, "Loss Payee**" must appear. NOTE: The inclusion of "Loss Payee" in the Description of Operations alone does not provide evidence of Hired-Auto Physical Damage. Hired-Auto Physical Damage Coverage must ALSO be shown on the Certificate.
